Notice of an Investigation into Alleged Restrictive Practices in the Medical Sector by Cellmed Health Medical Fund

IT is hereby notified, in terms of section 28 of the Competition Act [Chapter 14:28] ("the Act"), that the Competition and Tariff Commission ("the Commission") has commenced an investigation into an alleged restrictive practice by Cellmed Health Medical Fund. section 28 of the Act empowers the Commission to undertake an investigation into any restrictive practice, as defined in terms of section 2 of the Act, which the Commission has reason to believe exists or may come into existence.

It is alleged that Cellmed Health Medical Fund ("Cellmed") deregistered some healthcare service providers from the New Health 263 direct payment system resulting in Cellmed not honouring its members' claims after receiving medical services from any of the deregistered service providers. It is further alleged that the conduct by Cellmed has created an unfair playing field amongst healthcare service providers as Cellmed members are indirectly compelled to seek medical services from the few preferred healthcare service providers. It was also brought to the attention of the Commission that Cellmed is denying, without reasonable excuse, to register new service providers on its New Health 263 direct payment system.

It is further alleged that Cellmed established its health practice in Mhondoro Ngezi, where members get medical attention without paying any shortfall and that to stifle competition, CellMed introduced tariff reductions for external service providers.

The Commission has preliminary concerns that the allegations may result in members' choice of health service providers being limited to only a few preferred providers thereby stifling competition amongst the players and creating barriers to entry and expansion in the relevant market.

It should be noted that the commencement of the Commission investigation neither pre-supposes that the allegations being investigated are anti-competitive nor that Cellmed has violated the provisions of the Act. The Commission will, as provided in section 28 of the Act, conduct an investigation to determine whether the alleged practices directly or indirectly restrict competition.
